

Primo Gozney Roccbox Pizza Oven Competition

Terms and Conditions

Introduction

These terms and conditions form the basis of the Cornetts Supermarket (Cornetts) and Everfresh Food Market (Everfresh) Gozney Roccbox Pizza Oven competition.

There are 5 Gozney Roccbox pizza ovens that will be given away across the Cornetts and Everfresh stores.

1.0 Entry

- 1.1. To enter buy any Primo branded product (excluding Deli) between 1 December 2021 and 31 January 2022.
- 1.2. Entrants may enter multiple times for every Primo purchase (excluding Deli).
- 1.3. Entrants must enter all the required details online on the Cornetts (cornetts.com.au) or Everfresh (everfreshfoodmarket.com.au) website to be in the draw to win.
- 1.4. Entrants must keep their receipt with the proof of purchase and present the receipt if they are selected as one of the 5 winners.
- 1.5. If an entrant is drawn twice then then another winner will be selected for the second pizza oven as there can only be one pizza oven won per person.
- 1.6. Entrants will be bound by these terms and conditions which may be varied from time to time.
- 1.7. An entrant must notify Everfresh or Cornetts of any change of address and if not changed and the winner cannot be contacted this is not the responsibility of Everfresh.
- 1.8. Everfresh or Cornetts may withdraw an entrant from the competition without notice for any reason including, without limitation, if the entrant:
 - 1.8.1. Fails to comply with these Terms and Conditions,
 - 1.8.2. Abuses any member of staff, or
 - 1.8.3. Supplies any misleading information or make any misrepresentations.
- 1.9. Any tax, liability, or duty arising from entering in the competition is the responsibility of the entrant.

2.0 General

- 2.1. Everfresh or Cornetts may make any changes at any time without prior notice to these Terms and Conditions.
- 2.2. All entrants will be added to the Everfresh or Cornetts database for future marketing purposes for both email and SMS notifications.

- 2.3. The winner must collect the pizza over from the nominated store within 60 days of being notified.
- 2.4. A notice shall be deemed to be given by Everfresh or Cornetts to the winner if it is sent to the mobile phone or e-mail address of the entrant appearing in the entry database.
- 2.5. Everfresh and Cornetts assumes no liability for future use of the Pizza Oven or your cooking skills using said oven 😊.
- 2.6. These terms and conditions will be construed according to and be governed by the laws of Australia. The parties submit to the exclusive jurisdiction of the courts in and of Australia in relation to any dispute arising under these terms and conditions.

3.0 Privacy Statement

- 3.1. Everfresh and Cornetts may collect and retain information about entrants contained in the entry form. The membership database contains the following member information:

- 3.1.1. Name, address, email address & telephone number(s) and store details.

A member may access their information held by Everfresh or Cornetts by contacting the head office on email@cornetts.com.au. If the information is inaccurate or incomplete, the member may advise Everfresh or Cornetts to update the information.

- 3.2. Information from the entry database will be made available to the agents involved in administering the competition including marketing data processing. Information from the competition entry will also be made available to and used by Everfresh and Cornetts and their agents, for marketing (direct and all other kinds), planning, product development, research and other commercial purposes.
